

Applying for a Home-Based Business Checklist

1. Complete the HBB Application Packet
 - a. Application
 - b. AEF 210-70A Certificate of Understanding
 - c. AEF 210-70B Statement of Understanding
 - d. HBB Memorandum for Housing*
 - e. Request to Operate a HBB with Formal Business Proposal included.
 - f. Submit photocopy of Passport with SOFA stamp/card and a photocopy of your ID Card.
 - g. Print out the digital copy of the Housing Approval letter, and take it to the Garrison Housing Office. The Chief, Housing Division, approves the application confirming that the business will not have a negative impact on housing or community relations or be excessive in utility usage.

2. Depending on your location you will need to register at one of the Following German Trade Offices (Gewerbeamt):

3. *It is not required but you are encouraged to seek assistance from a German tax professional or legal advisor. It is your responsibility to comply with German tax laws and you may find that due to very little interest in HBBs in recent years, the Gewerbeamt in Birkenfeld is unfamiliar with what documents should be filed for a HBB on post. A tax professional can help you navigate this issue.*

3. Once the above steps are completed turn in all supporting documents to Deirdre Hogue, Private Organization Liaison, Phone: 0611-143-541-9079, Email: usarmy.rheinland-pfalz.id-europe.mbx.dfmwr-unit-funds@mail.mil, or in person at US Army Garrison Rheinland-Pfalz Headquarters, Rhine Ordnance Barracks, Bldg. 162, Rm. 117.

4. Once the Packet is Complete the Liaison will email the Commissary and AAFES to obtain their approval stating that your business is not in direct competition with any of their facilities.

5. After approval is received from the above parties, the Liaison will submit the entire packet for Legal Review and Garrison Commander Approval. The HHB Owner will be contacted by phone or email upon approval or denial of the request.

6. All approval documents will be sent to the HHB Owner, it is required to keep a copy of this approval on hand at all times. We recommend taking a photo with your cell phone for easy access.

Legal Advice is encouraged for guidance on trying to establish this HHB.
