DRACULA'S TRANSYLVANIAN HALLOWEEN LAND TRAVEL REGISTRATION PACKAGE

Instructions: This form must be filled out by the customer and returned to Kaiserslautern Outdoor Recreation in person or by email to Kaiserslautern Outdoor Recreation **before payment can be processed.**

This form may be filled out electronically (preferred) or filled out in **BLOCK CAPITAL LETTERS** in blue or black ink.

Page 1 - Payment Agreement

- A) Fill in **your name** in the first paragraph and signature blocks.
- B) Fill in the **number of spaces** requested.
- C) Unless you are making payment in full, **Leave Total price of The Trip and Deposit amount blank.** They will be filled in by ODR when you make your initial payment.
 - i) **If you are paying in full**, note the total price of the trip and leave the deposit amount blank.
 - a) This will be noted and the payment schedule and the section describing **non-refundable deposits will not apply to you.**
- D) **Date and sign** page 1.

Page 2 - Registration form

A) In **BLOCK CAPITAL LETTERS** fill in each passenger's travel document information, which **must match your passport exactly.** Each entry is **mandatory for the first passenger.**

i) Last name, First name and Middle Name/Initial matching your passport

ii) Date of Birth (Month/Day/4 digit year)

iii) Sex

iv) email address

a) At least **one valid email address is required.** You may include additional email addresses on lower entries

v) Cell phone number

a) At least **one valid cell phone number is required.** DSN or landline phone numbers may be entered on lower entries

B) Each passenger, regardless of age, requires their own entry in the form.

C) This form will be submitted to the airline for ticketing. Any name change fees caused by incorrect entries onto this form will be the responsibility of the customer and must be settled at the airport before your boarding pass will be issued.

Dracula's Transylvanian Halloween Land Travel Only Agreement

Outdoor Recreation will provide the Dracula's Transylvanian Halloween land package consisting of:

- Bus transportation starting at **Henri Coanda International Airport**, Bucharest
- 1 overnight in ***** **Novotel Bucharest City Center with breakfast**
- 3 overnights in **** **Hotel Kronwell** Brasov with **daily breakfast** and 2 dinners
- **Festive dinner** with welcome drink and entertainment at a traditional restaurant in **Poiana Brasov**
- **Dinner** at **Historic Restaurant Caru Ca Bere** in Bucharest with entertainment
- Guided tour of **Brasov**
- Guided tour of **Bucharest**
- Guided tour of **Sighisoara**
- Guided tour of **Parliament Palace**
- Night tour of **Bran Castle** on **Saturday, Oct. 28** hosted by Vlad Tepes
- Admission to **Bran Castle Halloween Party** in the Royal Gardens
- Admission to **Peles Castle**
- Admission to **Snagov Monastery**
- **Souvenir** at end of tour
- The land travel is being purchased by customer as a **complete package only**. **Discounts or refunds shall not be offered for un-used portions of land travel package.**

Land travel customer assumes all responsibility for transportation to and from Romania. Failure for any reason by the customer to meet the ODR group in Romania shall not be considered justification for a refund.

Land travel only package will start at **Henri Coanda International Airport** on 26 October, 2017, immediately after the landing of the ODR flight which is scheduled for 12:55 p.m.

- Customer agrees to meet the group at the airport at the designated time and date and is responsible for doing so.
 - If customer does not meet the ODR group at the airport, customer is responsible to meet with the group in Brasov. Expected arrival in Brasov is approximately 6 p.m. on 26 October, 2017.

Hotel Kronwell 7 Garii Blvd, Brasov

- Land travel customer will be able to check into hotel with or without the presence of the trip leader, only **after the trip leader has checked the group into the hotel** on the evening of 26 October, 2017.
- Land travel customer arrival at the hotel outside of these hours may result in **missed portions** of the tour package which **are non-refundable**.
- The **ODR group shall not deviate from the published itinerary** in order to pick up customer at any point in the travel.

Land travel package will end at **Bucharest Airport at approximately noon on 30 October, 2017.**

- The tour schedule **shall not deviate from the published itinerary** in order to meet earlier flights by land travel customers.
- If land travel customers need to arrive at Bucharest airport **before the group is scheduled to arrive at the airport**, customer must separate from group early and provide transportation to the airport at their own expense.
- Any **portions of the travel package missed due to early separation from the tour group by land travel customers shall be non-refundable.**

Additional lodging expenses incurred by land travel customers due to arrival in or departure from Romania on **dates different than the ODR group** are the **responsibility of the customer**, and are **not refundable** by Outdoor Recreation.

Additional expenses incurred by customer due to **failure to adhere to trip timeline** are **not refundable by Outdoor Recreation** under any circumstances.

The maximum total expenses refundable by Outdoor Recreation **under any circumstances** will be the total price of the trip, which will only be fully refunded due to **failure by tour operator to provide the trip as advertised** to the group as a whole.

- Any refunds by ODR for portions of the land travel package not provided as advertised (i.e. a hotel does not provide breakfast as advertised) will be refunded in proportion to the value of those not-provided portions of the package.

Cancellation by the customer will result in the following fees

- Before Tuesday, August 22: **10% cancellation fee**
- From **Tuesday, Aug. 22** until **Friday, Oct. 6** : **50% cancellation fee**
- **100% fee** for cancellations made on or **after Saturday, Oct. 7**
- Kaiserslautern Outdoor Recreations strongly suggests customer **purchase Travel Insurance** from a licensed vendor
